

# Waratah® fencing end user promotion

## 1 May – 30 June 2018

### Full Terms and Conditions

- Information on how to enter and claim the Waratah fencing end user promotion form part of these Terms and Conditions of offer. Participation in this promotion is deemed acceptance of these Terms and Conditions. This promotion only applies to “eligible claimants (customers/trading names)” who meet the conditions of all the terms below.
- Promotion is only open to residents of Australia. Employees of the Promoter and its agencies (including but not limited to Waratah’s distributors/resellers) associated with this promotion are ineligible.
- Subject to these terms, Liberty OneSteel Wire Pty Ltd ABN 59 000 010 873 (Liberty OneSteel) offers to pay via redemption to any eligible customer a “cashback payment” on “qualifying Waratah post products” of \$120 (including GST) for every 100 Jio® MaxY® / GalStar® MaxY posts or 400 Jio Star® / GalStar Extreme® posts (Level 1), OR \$320 (including GST) for every 200 Jio MaxY / GalStar MaxY posts or 800 Jio Star / GalStar Extreme posts (Level 2), OR \$600 (including GST) for every 300 Jio MaxY / GalStar MaxY posts or 1200 Jio Star / GalStar Extreme posts (Level 3), purchased in any one (1) single transaction from an authorised Waratah reseller in Australia during the promotion period.
- Subject to these terms, Liberty OneSteel offers to pay via redemption to any eligible customer an additional payment of \$200 (including GST) for every 100 x Jio MaxY/ GalStar MaxY or 400 x Jio Star / GalStar Extreme posts purchased above Level 3 (outlined in point 3) in the same single (1) transaction.
- Customers may “mix and match” Waratah Jio / GalStar products of any size from the same post category (Jio MaxY with GalStar MaxY OR Jio Star with GalStar Extreme) to meet the minimum requirements to become eligible for cashback.

- Subject to these terms, Liberty OneSteel offers to pay via redemption to any eligible customer \$125 for every \$5,000 (incl. GST), in multiples of \$5,000, spent on ‘qualifying Waratah Longlife Blue wire products’ purchased in any one (1) single transaction from an authorised Waratah reseller in Australia during the promotion period.

- All Made To Order (MTO) Waratah post products and Longlife Blue wire products that are not available in point 6 & 8 of these terms are **excluded** from the “qualifying Waratah products” and are not eligible for cashback. Other excluded products are: OneSteel Black Star posts, Blue Latch posts, Gripfast® Steel Trellis post products & Jio® post extension products. Full list of Made To Order products excluded from promotion are listed in point 22.
- Subject to these terms, Liberty OneSteel offers to pay via redemption to any eligible customer a 10% extra cashback payment when qualifying Waratah post products & qualifying Waratah Longlife Blue wire products are purchased in the quantities specified in these terms & in any one single (1) transaction from an authorised Waratah reseller in Australia during the promotion period. All entrants must claim a least one level on both Waratah posts and Waratah Longlife Blue wire products to be eligible for the 10% combination cashback bonus.
- This offer only applies to purchases of the qualifying Waratah post and Longlife Blue wire products purchased from Tuesday, 1 May 2018 to Saturday, 30 June 2018 inclusive (the “promotion period”). This offer is not available to any customer who purchases Waratah products for resale to any other person. Any customer who purchases Waratah products for which a refund is subsequently given (other than due to a defect in materials or workmanship) will not be eligible to receive cashback payments.
- Eligible customers must complete an online claim form at [www.waratahfencing.com.au/cashback](http://www.waratahfencing.com.au/cashback) and together with an invoice as proof of purchase, carry out the instructions stated on the claim form. The claim form must be completed by no later than 5.00pm (AEST) on Thursday, 26 July 2018. Only electronic invoices that clearly state the name of the supplier/reseller of the Qualifying Waratah Products, the customer’s name, an invoice number, the quantity and unit price of the Qualifying Waratah Products purchased and the date of purchase of such products will be accepted as proof of purchase (incomplete or incorrect forms or invoices will result in delays). Hand written invoices will not be accepted as proof of purchase. Liberty OneSteel reserves the right to request additional proof of purchase or to verify any purchase directly with the supplier/reseller. For a claim to be valid, eligible claimants must upload a scanned or photographed copy of the original purchase receipt/invoice whilst submitting the online claim form. Incomplete, indecipherable, illegible or late claims will be deemed invalid.
- Subject to compliance with these terms, cashback payments will be paid by Liberty OneSteel in the form of a Visa card by no later than Friday 26 October 2018 and will be sent to the customers address specified on the claim form. Incomplete or incorrect invoices or claims will result in a delay of payment.
- Liberty OneSteel reserves the right, at any time, to modify these terms, verify the validity of claims (including contacting the place of purchase) and to disqualify any customer who submits a claim that is not in accordance with these Terms and Conditions or who tampers with the claim process. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights. Other conditions may apply.
- The customer agrees that if they have obtained the cashback, they will pay back the Promoter the value of the cashback, if they subsequently return the product to the place of purchase and seek a refund under any returns policy that the relevant reseller may have.

16. Customers must retain a copy of their tax invoice for all claims as proof of purchase. Failure to produce the proof of purchase for all claims when requested may, in the absolute discretion of the Promoter, result in invalidation of ALL of a customer's claims and forfeiture of any right to cashback. The tax invoice must clearly specify the store of purchase, tax invoice number, purchase date, products purchased, quantity purchased and unit price to verify the claim.
